### Important Obituary Information

### Why Obituaries Are Important

Obituaries lend a sense of the legacy a person leaves behind when they die. Writing your obituary (or at least providing many of the details) is a great way to share with your family some of the details of your life they may not know.

Obituaries are helpful in tracing genealogy. As the hobby of genealogy becomes more popular—and easier with computer records and the internet—writing a thorough and accurate obituary will assist your descendants in the future.

You will be giving your loved ones a great gift now, and especially at the time of your death. Gathering information and creating an obituary are difficult during times of grief. Beginning the process now will give your loved ones a head start at writing your obituary when you die.

You are the best source of the accurate facts about your life. Putting in writing everything you know about your life will prevent any mistakes when your obituary is written.

Taking the time to begin gathering information and writing your obituary will set an example for your family. It will show them you are helping *them* by taking care of the business of dying now so they don't have as much to do later. Having seen what you've done for them, they will likely do the same for their family.

Start now—refine later. You don't have to write the perfect obituary today but, if there are favorite stories or quotes you want included in your obituary, take time to jot them down now so your family will know to include that information in your final obituary.

Think about which newspapers you'd like your obituary to appear in so you can include it with your wishes. Some people have their obituary sent to the city where their vacation home is located—especially if it's out of state. Perhaps you grew up and lived in one area and retired to another to be closer to family. You may want to have your obituary sent to your hometown newspaper (again helpful with genealogy).



### Important Obituary Information

### Special Considerations

- ✓ Choose and set aside a photo of yourself you like. Head/shoulders is best.
- ✓ You don't have to write your actual obituary, if you don't want to, but having many of the details in place will make it easier for your family when the time comes for it to be written!
- Request ten death certificates from the funeral home. You can add this in to your funeral planning.
- ✓ Designate a family member to promptly notify the Social Security Administration of the death. This is important for receiving death benefits, as well as avoiding identity theft. (Note: funeral home may do this for you. Ask your funeral director about this process.)
- ✓ Designate a family member to mail original death certificates to all three credit reporting agencies, with the contact information of the family member who will do this. The agencies are: Equifax, Experian and TransUnion. Also contact all credit issuers to close accounts (bank credit cards, department store credit cards, etc.)
- ✓ By law, you are entitled to a free credit report every year. 6-8 weeks after the death, use this service to ensure no new credit has been established in the name of the deceased. Designate a family member to retrieve your credit report. The web address is: <a href="https://www.annualcreditreport.com">www.annualcreditreport.com</a>
- Designate a family member to contact Secretary of State/DMV to cancel any driver's license/voter registration to prevent duplicates from being issued.
- Don't include mother's maiden name in obituary as this is often used as password information.
- ✓ Don't include personal address information in your obituary. Consider asking a trusted neighbor or hiring someone to be at your home during the funeral to avoid anyone stealing from your home while everyone is at the funeral. Burglars who target the deceased and bereaved are known as "obituary thieves". They scan the obituaries for funeral information and strike when they know families will be away from the home of the deceased.
